## **Entries Close:**

Day of firing, 8:30 A.M.

There will be no refunds for those canceling after firing starts.

<u>Fees:</u> Fees include entry in all fired and aggregate individual matches and NRA registration fee. <u>Make all</u> checks payable to I.S.R.A.

• All competitors: \$20.00 per competitor, per day

<u>Eligibility:</u> Competition is open to all shooters. Any competitor being unsafe or disruptive may be told to leave the range.

Entry Limit: 42 competitors for each date.

<u>Rifles Allowed:</u> Rifles falling under rules 3.1 (Service Rifles) or 3.3 (Match Rifles).

Ammunition Allowed: Any safe ammunition may be used.

Empty Chamber Indicator (ECI): Empty chamber indicators conforming to rule 3.21 are required to be used at all times except during the preparation period and firing. Approved ECIs will be available at the stat office for no charge.

<u>Squadding:</u> All matches will be pre-squadded. Any competitor failing to report for his/her scheduled relay will forfeit his/her right to fire in that event.

**Scoring:** Competitors will score on their assigned relay. Failure to do so may result in tournament disqualification.

<u>Target Service:</u> The Silver Mountain Target System will be used, competitors are encouraged to bring a wi-fi enabled device (tablet, smartphone, laptop, etc.) to be able to see their shots as well as to score for others.

Range-owned devices are available for loan, but supplies are limited.

<u>Classification:</u> NRA Highpower classification will be used for reference purposes only.

## Course of fire:

- Match 1: 2 sighting shots, 20 shots for record slow fire standing on the SR target from the 200 yard firing line. Time limit: 12 minutes.
- Match 2: 2 sighting shots, 2 ten shot strings rapid fire, sitting or kneeling, on the SR target from the 200 yard firing line. Time limit: 60 seconds for each record string.
- Match 3: 2 sighting shots, 2 ten shot strings rapid fire, prone, on the SR-3 target from the 300 yard firing line. Time limit: 70 seconds for each record string.
- Match 4: 2 sighting shots, 20 shots for record slow fire prone on the MR-63 target from the 300 yard firing line. Time limit: 22 minutes. Downrange targets will use the MR-63 face for this stage.
- Match 5: Aggregate. Aggregate of stages 1, 2, 3, &

<u>Challenge Period:</u> The challenge period ends ½ hour after posting of match results.

<u>Awards:</u> Match and class winners will be recognized but monetary awards will not be distributed.

<u>Tournament Results:</u> A match bulletin will NOT be mailed. Final results will be posted approximately 30 minutes after firing has completed for the day. Printed match results may be picked up from the stat office at that time or viewed at <a href="http://www.illinoishighpower.org">http://www.illinoishighpower.org</a>. Those competitors not wishing to have their names on the web site MUST notify the stat office by the conclusion of the tournament.
