

# 2022 Illinois Service Rifle Championship

# NRA Registered Official Tournament Program

<u>Date:</u> September 3 - September 4, 2022. Firing will begin each day at 9:00 A.M. Stat office will close at 8:30. Please arrive early for squadding and registration.

Location: Milan Rifle Club, Milan, IL. Camping with electricity and outdoor toilet facilities is available.

Rules: Current NRA Highpower Rifle Rules will apply

## **Entries Close:**

Individual: September 3, 2022, 8:30 A.M. Team: September 4, 2022, 8:30 A.M.

There will be no refunds for those canceling after firing starts.

Team entry will include team name, names and classifications of firing members, and designated captain. Team members not entered in the individual matches must submit appropriate NRA registration fee.

<u>Fees:</u> Individual fees include entry in all fired and aggregate individual matches and NRA registration fee. <u>Make all</u> checks payable to I.S.R.A.

Individual (Adults): \$40.00 (Includes \$5.50 NRA Registration Fee) Individual (Juniors): \$20.00 (Includes \$5.50 NRA Registration Fee)

Team (Sunday): \$15.00/Firing Member (+\$6.00 registration fee for those not firing on Saturday)

<u>Eligibility:</u> Open to all competitors. NRA membership is not required. Any competitor being unsafe or disruptive will be told to leave the range.

Entry Limit: 68 individual entries (4 relays), 17 four-man teams.

Rifles Allowed: Only rifles falling under NRA rules 3.1 (Service Rifles) will be allowed to fire for awards.

<u>Empty Chamber Indicator (ECI):</u> Empty chamber indicators conforming to rule 3.21 are required to be used at all times except during the preparation period and firing. Approved ECIs will be available at the stat office for no charge.

<u>Squadding:</u> All matches will be pre-squadded. Competitors/team captains will receive scorecards and squadding when they report to the stat office upon arrival at the range. Any competitor failing to report for his/her scheduled relay will forfeit his/her right to fire in that event.

**Scoring:** Competitors will score on their assigned relay. Failure to do so may result in tournament disqualification. Team scoring procedure will be announced the morning of the team match.

<u>Target Service:</u> Competitors/team members will perform pit duty on their assigned relay. Hired target pullers may be used but the competitor/team who hired them will be held responsible for their target pulling performance. Unsatisfactory target operation may result in individual or team tournament disqualification. Due to the relay schedule, some competitors may be required to pull targets for more shots than other competitors.

<u>Classification:</u> NRA Highpower classification will be used. Those without a highpower classification may be assigned one (Rule 19.6) or they will compete in the Master class (Rule 19.7).

#### Course of fire:

#### Individual matches (Saturday)

- Match 1: 2 sighters, 20 shots for record slow fire standing on the SR target from the 200 yard firing line. Time limit: 22 minutes.
- Match 2: 2 sighters, 2 ten shot strings rapid fire, sitting or kneeling, on the SR target from the 200 yard firing line. Time limit: 60 seconds for each record string.
- **Match 3:** 2 sighters, 2 ten shot strings rapid fire, prone, on the SR-3 target from the 300 yard firing line. Time limit: 70 seconds for each record string.
- Match 4: 2 sighters, 20 shots for record slow fire prone on the MR-1 target from the 600 yard firing line.
   Time limit: 22 minutes.
- Match 5: The Woody Coul Trophy match. Aggregate of matches 1, 2, 3, & 4.

#### Team matches (Sunday)

- The Bliss Trophy team match. Consists of the following stages:
  - 1. 20 shots for record, per team member, slow fire standing on the SR target from the 200 yard firing line. Time limit: 43 minutes per pair of shooters.
  - 2. 2 ten shot strings, per team member, rapid fire, sitting or kneeling, on the SR target from the 200 yard firing line. Time limit: 60 seconds for each record string.
  - 3. 2 ten shot strings, per team member, rapid fire, prone, on the SR-3 target from the 300 yard firing line. Time limit: 70 seconds for each record string.
  - 4. 20 shots for record, per team member, slow fire prone on the MR-1 target from the 600 yard firing line. Time limit: 43 minutes per pair of shooters.

#### **Awards Schedule:**

#### **Individual Matches 1-5:**

The highest scoring competitor in each match will be named match winner and receive an award.

Category awards for High Woman, High Service, High Senior, and High Junior will be awarded to the top scoring member of that category in each match provided there are at least five competing members of that category.

Class awards will be awarded depending on the number of competitors in each class. There must be a minimum of 4, 7, 10, 14, and 17 entries for 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> respectively, in class awards. If there is less than the minimum number of competitors in a class, that class will compete in the next higher class. If there is less than the minimum number of High Masters, they will compete for Match Winner only.

The 10 highest scoring Illinois residents in match #5 will be recognized as the "Governor's Ten".

The Woody Coul Trophy Plaque will be presented to the high scoring Illinois resident in match #5.

#### Bliss Trophy Team Match:

Each member of the highest scoring Illinois team will receive picture plaques of the <u>Bliss Trophy</u>. Monetary awards will be given to the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place teams in each class provided there are 3, 5, and 7 teams respectively.

**Challenge Period:** The challenge period ends ½ hour after posting of match results.

<u>Awards Ceremony:</u> An awards ceremony will take place in front of the stat office approximately 20 minutes after firing has completed each day. All tournament awards must be accepted at that time or other arrangements made with the stat office. Awards not collected will be forfeit.

<u>Tournament Results:</u> A match bulletin will NOT be mailed. Printed match results may be picked up from the stat office or viewed at <a href="http://www.illinoishighpower.org">http://www.illinoishighpower.org</a>. Those competitors not wishing to have their names on the web site MUST notify the stat office by the conclusion of the tournament.



# C.M.P. Excellence-In-Competition Rifle Match In conjunction with the 2022 Illinois Service Rifle Championship Official Match Program

**Eligibility:** Open to anyone conforming to CMP Eligibility Requirements (Rule 2.0).

<u>Date:</u> Monday, September 5, 2022. Firing will begin at 9:00 A.M. Stat office will close at 8:30 A.M. Please arrive early for registration and squadding.

Location: Milan Rifle Club, Milan, IL.

Fee: Make all checks payable to I.S.R.A.

Adult Entry: \$25.00 Junior Entry: \$15.00

### Course of fire: Rifle National Match Course of fire (Rule 5.4)

- Stage 1: 10 shots for record slow fire standing on the SR target from the 200 yard firing line. Time limit: 10 minutes. The sling may be attached to the rifle in the parade position, but may not be used for support.
- Stage 2: 10 shots rapid fire, standing to sitting or kneeling, on the SR target from the 200 yard firing line. Time limit: 60 seconds.
- Stage 3: 10 shots rapid fire, standing to prone, on the SR-3 target from the 300 yard firing line. Time limit: 70 seconds.
- Stage 4: 20 shots for record slow fire prone on the MR-1 target from the 600 yard firing line. Time limit: 20 minutes.

<u>Authorized Rifles:</u> M16/AR15-Type Rifles (Rule 4.1.1), CMP Alternative Rifles (Rule 4.1.2), M14 Type Rifles (Rule 4.1.3), M1 Garand Type Rifles (Rule 4.1.4). Any safe ammunition may be used.

**Entry Limit:** 68 Competitors with squadding priority to non-distinguished shooters. A minimum of 6 non-distinguished shooters are required.

<u>Awards:</u> Credit towards the Distinguished Rifleman badge and appropriate Excellence-In-Competition badges. Results available at the match are preliminary until finalized by the CMP or appropriate branch of service.

Rules: This match is governed by the current CMP Competition Rules.
